Idle Valley have been contacted regarding the boundary fence near Rabbit Lane being removed following Idle Valley nature reserve cutting the grass in Linghurst Lakes. They have been reminded that this is not their land, and the grass does not need cutting by them. Signage to placed near the location. Situation to be monitored.

07.21.06 Reports from County and District Councillor County Council:

Cllr T Taylor reminds every one of the websites, County Council hub and app in relation to referring people to Covid related concerns and issues.

FCC have still not submitted an active Environmental Impact Statement, a licence to operate has been requested to the EA but this is not yet a live consultation - but is likely to be imminent.

Full Council was held 2 weeks ago, regional devolution partnership was discussed with a view of having an elective mayor this is to be investigated further.

Post Covid recovery and ICS (health services) were also discussed.

The Big Notts survey is currently live. The information will be used to craft a 10yr plan for Notts. The links are available on the county council website. Cllr T Taylors urges everyone to have their say to shape the plan.

District Council:

Several meetings to take place within the next few weeks to discuss lack of policing and other issues that we feel requires additional support.

As an aside the Farmer who was shot at near to our Parish in the alleged theft case, was told no Police action was going to be taken.

Daneshill Waste Cycling development is also gathering momentum with plans to hold a discussion group with Chairs of PC and other parties as this progresses.

The verge on Little Top Lane is maintained by a resident and has been left to encourage wildlife. The area near the nursing home is to be added to the monthly grass cut.

Multiple complaints have been received about vegetation and the condition of the footpath along Town Street. This has been reported to Notts County Council.

A further request for a road sweep along Town Street in to be put into district council.

Oranmore have now taken over the Charcon site.
