The FCC Daneshill planning inspectorate inquiry is discussed, Cllr F Wilson MacCormack agrees to take the support lead in representation of the Parish Council and will offer updates, support and advice to residents on the matter. A budget of £100 is agreed to cover hall hire, and administration as necessary.

04.24.04 Minutes:

04.24.05 Matters arising from previous periods carried forward:

The breeze seat has now been repaired in the playing field. A spare seat and the specialised tool is to be stored in the Reading Room.

04.24.06 Reports from County and District Councillor

District Council:

An update on the boundary commissions consultation review is given, BDC have submitted a slight change to the Sutton ward which includes Torworth, aligning the electorate numbers to around 2000 people per council member. As part of the review various ward name changes have also been suggested.

County Council:

The Daneshill/ Chainbridge crossroad works alteration from 'give way' to 'stop' is scheduled for this year's works plan.

The recent newspaper headlines regarding the alleged closure of various waste sites are reported as balderdash possibly relating to political campaigns in play. A public consultation has taken place, and the results of this are being worked through, at this point no formal recommendations have been made or agreed.
