

The east fence boundary around the playing field needs repairing/ replacing. The landowner owning the small patch of land in between the playing field and village green to be contacted.


The chains on the carousel swing have all been replaced. Some wear and tear on the seats is reported, and to be monitored.

Cllr M Naylor and A Jones to cut back the growth at Poplar Walk (the footpath from Chainbridge to Neatholme)


### 06.24.11 Tree Warden, Green Warden & Footpath Wardens
