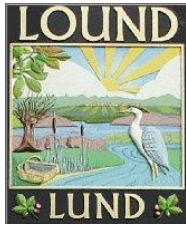
Cllr Jones and Naylor have cleared the Poplar Walk path.

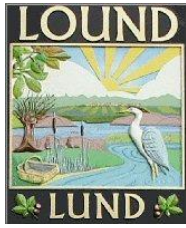
07.24.09 Finance
