
10.24.04 Minutes:

10.24.06 Reports from County and District Councillor

Cllr T Taylor updates on the last Cabinet meeting which included debate on Winter fuel payments, household waste centres and solar farms, the outcome being that it was resolved where the decision lays with NCC to determine the planning outcome, they will seek to protect our agricultural land.

The NCC Local Community Fund has opened for bids.

The FCC planning applications: Daneshill Landfill Site, Daneshill Road, Lound, DN22 8RB V/4613, V/4614 V/4615 which seek to extend the period of works and then restoration period to 2037, are all scheduled for determination by Notts Planning Committee during the month. The Parish Council ask Cllr T Taylor to represent the parishes views in objection requesting that the land, as per the original planning agreement is restored.




